THERE ARE ALL TOGETHER 191 VILLAGE PANCHAYATS IN GOA. 179 PANCHAYATS ARE HAVING THEIR OWN PANCHAYAT GHARS. 134 PANCHAYAT GHARS ARE IN VERY GOOD CONDITIONS. 56 PANCHAYAT GHARS NEEDS REPAIRS OUT OF WHICH 43 ARE PROPOSED FOR RENOVATION AND FOR CONSTRUCTION OF NEW BUILDING UNDER GSIDC AND GTDC UNDER DEENDAYAL PANCHAYATI RAJ INFRASTRUCTURE DEVELOPMENT (GOLDEN JUBILEE) SCHEME, 2013. UNDER THIS SCHEME THE GOVERNMENT HAS GRANTED MAXIMUM OF RS. 2,00,00,000/- TO UNDER TAKE THE INFRASTRUCTURE DEVELOPMENT PROJECT INCLUDING CONSTRUCTION OF PANCHAYAT GHARS. THE SAID AMOUNT WILL BE ENHANCED TO 3.5 CRORES. THE PROPOSAL OF WHICH IS UNDER CONSIDERATION OF THE GOVERNMENT.

IN ADDITION TO THIS 4 PANCHAYAT GHARS ARE PROPOSED TO BE CONSTRUCTED UNDER RGSA (RASHTRIYA GRAM SWARAJ ABHIYAN). NO PROPOSALS HAVE SO FAR BEEN RECEIVED FROM 4 PANCHAYATS TILL DATE.
